

## Accessibility Statement for the website web <https://clampco.it/>

Clampco Sistemi S.r.l. is committed to providing transparent information on the level of conformity of its website with accessibility requirements.

Pursuant to **Legislative Decree of 27 May 2022, No. 82**, which transposes **Directive (EU) 2019/882 (European Accessibility Act)**, and, where applicable, the **Digital Administration Code (Legislative Decree of 7 March 2005, No. 82, as subsequently amended)**, the accessibility status of this website is hereby disclosed.

### 1. Conformance status

The website <https://beeup.it/> is **partially conformant** with the requirements set out in the technical standard **UNI CEI EN 301 549** and the **WCAG 2.1 AA** (Web Content Accessibility Guidelines), which are recognized as reference standards for web accessibility.

This statement is based on an **internal self-assessment carried out on 18 June 2025**.

No certification from third parties is currently available.

### 2. Reasons for partial conformity

The website was **developed prior to 28 June 2025** and presents technological constraints that do not allow full compliance with certain accessibility criteria.

Identified issues include:

- navigation with assistive technologies not always clear
- occasional insufficient color contrast
- links and buttons with descriptions not always adequate
- incomplete heading structure
- images without alternative text

### 3. Accessibility plan

Clampco Sistemi S.r.l. acknowledges the importance of accessibility as a tool for inclusion and equal opportunities. Website adjustments will be carried out progressively and in proportion to available resources, with the aim of meeting the deadlines established by European legislation.

The final deadline for achieving **full compliance is set for 28 June 2030**, as provided under the EAA framework and Legislative Decree 82/2022 for services/products already in use prior to 28 June 2025. Each intervention will be accompanied by an updated revision of this statement, made publicly available in this section.
